Preamble :-

The State Government is implementing the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) under the Maharashtra Employment Guarantee Act 1977 (as amended 2006) since 2006.

The districts implementing MG-NREGS have been receiving the funds directly from Government of India, and the proportionate share of the State Government for the material portion are being transferred to the district.

Now Government of India has directed that the State Government constitute the State MG-NREGS fund to receive funds from Government of India and transfer to the districts for implementation of the scheme. In this regard the Government of Maharashtra has taken following decision.

Government Resolution :-

1. After careful consideration the State Government gives approval for creation of a fund to be called 'Maharashtra State MG-NREGS Fund'.

2. The fund shall be credited with -

a) Monies/ Central share received from the Government of India for implementation of Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS)

b) Maharashtra Government's share of contribution to the MGNREGS (State Share)

c) Contribution from Statutory bodies created under the Act of Parliament or of the State Legislature, United Nations and its associated bodies etc; provided that there are no conditions attached to such contributions.

d) Miscellaneous receipts viz; Interest accrued etc.

3. Opening of Savings Bank Account

The Maharashtra State MG-NREGS fund shall be maintained in Bank Account, which shall be opened in Nationalised Banks and operated by the senior officers with joint signatures to be decided by the Executive Committee of the Society.

4. Constitution of a Society

The State Government shall create a Society to be called 'Mahatma Gandhi National Rural Employment Guarantee Scheme fund Association (Maharashtra)' under the Societies Registration Act 1860, for administration and management of the State MG-NREGS fund.

The Society shall be a Government Society with a Governing Board and an Executive Committee which shall be delegated the powers for day to day administration of the said Society. Being Government Society the office bearers of the Society will hold their position in the Society ex-officio.

Seven members of the Governing Body shall constitute the founder Members of the said Society.

The Society is mandated with implementing the scheme in the State and to do all such acts for its effective implementation.

The members of the Governing Board proposed (Ex. officios) are given in Annexure.

A GR for covering the detailed framework of the Society is being issued separately.

5. Transfer of funds to district for implementation of MG-NREGS.

1) Funds may be released towards 1st installment from the Saving Bank account to the District Programme Coordinator (DPCs) as per the labour budget and requirement of funds based on demand for works.

2) Further fund releases to the District Programme Coordinators (DPCOs) shall be made based on the requirement, utilization of funds already released and expenditure particulars thereon.

3) Government may put any pre-requisite and add/alter/modify the conditions for release of funds to districts from time to time

6. Accounts and Audit

1) Standard accounting procedures shall be followed in respect of maintenance of Maharashtra State Employment Guarantee Fund and necessary entries such as cash book, ledgers etc. shall be maintained.


2) Annual accounts shall be prepared in the prescribed formats and audited by the Chartered Accountants.
